***Agreement Terms for All Renters & Organizations Using
the Alix Agricultural Grounds Facilities***

WE ARE A VOLUNTEER ORGANIZATION PROVIDING OUR
COMMUNITY WITH A FACILITY FOR EVERYONE TO USE & ENJOY.

TERMS FOR USE OF FACILITIES & GROUNDS:

1. Campfires only allowed in fire pit(s) provided.
2. All dogs must be kept on a leash.
3. Be respectful of the neighboring residential area as to not create a disturbance with loud music, vulgar language, ect.
4. Be mindful & respectful of other groups that may be using/renting other areas of the ground at the same time.
5. Fireworks are not permitted.

PLEASE ENSURE THE FOLLOWING ITEMS ARE TAKEN CARE OF BEFORE LEAVING THE PREMISES AFTER EACH USE:

1. All floors are to be mopped & swept- kitchen, bathrooms, hallway & main building.
2. All counter tops, tables, sinks, toilets & showers to be cleaned.
3. Kitchen appliances to be cleaned out if used- stove, oven, microwave, coffee urns, fridges & any other utensils, ect.
4. Fans & main lights to be shut off & heat turned down, as instructed by Ag Society Facility Caretaker.
5. Check to make sure that all water taps & hydrants are completely turned off.
6. All garbage, from inside & outside, to be put in garbage bags & placed into the steel garbage dumpster (east of buildings). Please only normal facility use garbage. Clean garbage bags to be put in containers.

That means- no tents, tent poles, broken lawn chairs, area rugs, small kitchen appliances... etc. We care about the environment we live in. Thank you for using the bottle recycle container for your empty beverage containers.

7. All dog & pet litter is to be picked up, bagged & put in garbage dumpster.
8. Barns must be cleaned out, stalls stripped off, manure deposited on pile east of barns in bunker. Clean up your manure from trailer parking area.
9. Any outdoor benches & tables are to be placed back where they were found.
10. All signs put up to direct people to your event at the Ag Grounds must be taken down & disposed of properly.

CLEANING SUPPLIES ARE FOUND UNDER THE KITCHEN SINK. WE ASK THAT YOU USE THIS PREMISE WITH GREAT CARE. AFTER EACH USE, THIS FACILITY REA ARE INSPECTED FOR CLEANLINESS AND DAMAGES.

Failure to adhere to these guidelines may result in loss of your damage deposit!
